

Dear Parents of the CES Class of 2020:

NOTE: If this form and deposit is NOT received by May 1, 2019, you will automatically be a Buy-Out Family!

Planning has begun for the Class of '20 Fairview Lake 6th grade field trip next year. The cost of the field trip is the sole responsibility of the parents and is estimated to be between \$500 - \$550. This amount covers the cost of 4 days, 3 nights at the YMCA Camp, meals, transportation, and a full schedule of environmental activities.

Families will have two payment options for the trip: 1) Buy-Out or 2) Fundraising

Option 1: Buy-Out Option

- You can choose to "buy out" by paying for the full cost of the trip.
- You will not be obligated to participate, volunteer, or chaperone at any of the fundraising events.
- The first payment of **\$300** will be due on **Wednesday, May 1, 2019**.
- The final payment will be tentatively due in November of 2019 and is estimated to be about \$ \$200 - \$250.
- Changes may be made to the final cost based on administrative decisions and fundraising.

Option 2: Fundraising Option

- This choice provides you with the benefit of fundraising as a group to offset the cost of the trip.
- The first payment of **\$100** will be due on **Wednesday, May 1, 2019**.
- Fundraisers will take place through January 2020. Your final payment amount will be communicated to you starting in the Fall based on the fundraising credits you earned.
- To be considered a fundraising family, you must meet the following minimum obligation:
 - sign up as a Chair/Co-Chair for one event, OR
 - participate as a volunteer/chaperone in a minimum of 3 fundraisers
- You may sign up for additional fundraisers to increase your fundraising total.
- As a Chair of an event it is your responsibility to organize the entire fundraiser. You will receive 10% of the fundraising total for your event toward your child's trip. If two people co-chair an event, you will each receive 5% of the fundraising total toward your child's trip.
- As a volunteer/chaperone for an event, you will receive 2% of the fundraising total toward your child's trip.
- The remainder of the money raised from each fundraiser will go into a pool to be evenly divided among all of the fundraising families that met the minimum obligation. You will be removed from the pool if your obligation is not met.
